

The AAMA website is new and improved! You no longer need to use your last name and ID number to sign in to the website. You will need to create a new account using your e-mail address.

Extra Tip: For access to personal and professional information, such as your CEU transcript, sign in and click on "My Account" in the upper-right corner.

Recertify Online with AAMA CEUs - all of your CEUs appear on your AAMA CEU Transcript and it is within 30 days prior to your certification expiration date, apply online.

Recertify by Phone with AAMA CEUs - if all of your CEUs appear on your AAMA CEU Transcript, you do not need to fill out the application:

Call the AAMA Continuing Education Department at 800/228-2262. Have your credit card handy. (Recertification status will not be determined at the time of your call. As with mail-in applications, processing may take up to 30 days.)

The quickest way to join or renew your membership with AAMA is online.

While our two main fax numbers (312/899-1259 and 312/899-8391) still are in operation, we now also have some direct fax numbers to expedite some of the items you are sending.

Rosters and labels can be requested from the website under the volunteer button drop-down menu.

Marketing materials can be ordered through the website store. Both can be accessed 24/7, when it's convenient for you.

How members are placed into chapters. Zip codes for chapters are provided to the national office by the state society president. Staff does not place members into chapters. The computer system automatically places members according to the zips provided by the state president. We suggest that state societies audit their zip codes periodically. If you would like to request a listing of the zip codes for your state, the state president can email us a request. Our team will make the changes you provide to us. If a member does not have a chapter near enough for a zip code assignment, they will be members-at-large within the state. Members can always call the national office and ask to be assigned to another chapter. The chapter reassignment will be locked in until another change is indicated by the member.


Informing You For a Better You

When working outside we need to be smart about the way we dress and think so that we can stay safe this winter:

Two big concerns of working or simply spending time outdoors in cold weather are frostbite and hypothermia. Both can occur at much higher temperatures than many people realize. For example, exposed skin can start to freeze at just 28 degrees Fahrenheit (-2 degrees Celsius) and deep frostbite can cause blood clots and even gangrene. Hypothermia is a potentially fatal condition caused by loss of body temperature, even in winter conditions people might not consider particularly nasty. Symptoms include fatigue, nausea, confusion, lightheadedness and

profuse sweating. Without medical treatment, the victim can lose consciousness and





· Dress in layers of lightweight clothing, which keep you warmer than a single layer of heavy clothes. Remove layers as necessary to prevent overheating and perspir-

ing, which can lead to chills or hypothermia later. Remember that wet clothing is 20 times less warm than dry clothing. Wear a hat and you will stay much warmer when working in cold conditions. As much as half your body heat can go up in steam off the top of a bare head. Protect your ears from frostbite as well by wearing a hat that will cover your ears, or use earmuffs.

- While wearing a scarf or muffler might help keep your neck warm in the cold weather, it could also kill you if you work near rotating machinery. Check your winter wardrobe for entanglement hazards such as loose sleeves and dangling drawstrings.
- Keep your safety eyewear from fogging up in the cold. Investigate anti-fog coatings and wipes to see if these products are appropriate for your eyewear. If you have to keep taking off your safety eyewear because it fogs up, it is not protecting you.
- Look at the soles of your winter footwear. Your shoes or boots should have adequate tread to prevent slips and falls on wet or icy surfaces. For extremely slippery situations, you can attach clogs or cleats to your footwear. Slow down when walking across slippery surfaces and be especially careful on ladders, platforms and stairways.
- Get plenty of rest. Working in the cold and even traveling to and from work in the winter takes lots of energy. Cold weather can strain your heart, even if you are not overexerting yourself, so be sure to pace yourself when lifting heavy objects or shoveling snow.

CERTIFICATION/EDUCATION COMMITTEE:

The purpose of this committee is to promote AAMA certification and recertification throughout Nebraska. Certification is or should be the goal of all medical

assistants and achieving it is one of the most important steps in becoming a professional medical assistant. Achieving the CMA (AAMA) credential is evidence of competence in a demanding field. Per AAMA, a greater number of employers are preferring that their medical assistants be CMAs (AAMA) due to the reputation of the credential being the gold standard for the profession. Thus, CMAs (AAMA) comprise the majority of credentialed medical assistants in the workforce today.

The Certification Committee Chair and all committee members must be current CMAs (AAMA) and promote the AAMA policy that all working CMA's (AAMA) must remain current.

The Chair should maintain an effective level of political awareness regarding the medical assistant's right to practice and notify the NSMA Public Affairs Chair of any threats to the profession or noteworthy developments.

Chair is automatically a member of the NSMA Education Committee and shall be available to assist in coordination of educational programs.

Effective January 2008, the American Association of Medical Assistants certification title was changed and the proper official abbreviation is now CMA (AAMA). Chair shall market and promote the proper use of nametags in the workplace designating "CMA (AAMA)" as the correct professional title for those who qualify.

The CMA (AAMA) credential is awarded to medical assistant candidates who have successfully completed the AAMA certification/recertification exam administered by the Certifying Board of AAMA. The National Board of Medical Examiners® serves as test consultant for the CMA (AAMA) exam. As a result, the reliability and validity of the CMA (AAMA) credential is of the highest order. Only graduates of post-secondary medical assistant programs accredited by either CAAHEP or ABHES are eligible to take the CMA (AAMA) examination.

The certification exam is a comprehensive test of knowledge including administrative functions, clinical procedures and other general medical assistant activities in the medical office. Content breakdown includes anatomy and physiology, terminology, behavioral science, professionalism, communications, computer concepts, records management, practice finances, infection control, nutrition, collecting and processing specimens, medico legal issues, medication preparation and administration, examination room techniques, emergencies, etc. The examination is updated and reconstructed annually by the AAMA Certifying Board.

Chair should encourage and be available to assist Chapters and medical assisting schools in forming study groups to support candidates preparing for the exam. Candidates may be referred to the AAMA website, Candidate Application and Handbook document. Beginning January 2009, AAMA instituted continuous computer based testing (CBT) with immediate provisional

results for the certification examination. The AAMA website will provide step-by-step instructions on how to complete the exam application, confirm eligibility, list required documentation, current fees, testing locations and appointment information. It is recommend that all applicants review the CMA (AAMA)

Certification/Recertification Examination Content Outline and take the practice exams on line prior to official testing.

On verified successful completion of the exam, the AAMA Certifying Board (CB) will send a certificate, identification card and a CMA (AAMA) lapel pin to all new CMAs (AAMA). Recertifying CMAs (AAMA) will receive a certificate and wallet card.

To maintain the credential, CMA's (AAMA) are required to stay current in the medical assisting field by regularly updating skills and their knowledge base. Since 1988, a CMA (AAMA) must recertify every five years and failure to do so results in a "not current status." Effective January 2003, all certified medical assistants employed or seeking employment MUST have current status in order to use the CMA credential. The current or not current status of all CMA's (AAMA) is of public record and can be ascertained by contacting the AAMA Executive Office.

All newly certified and recertifying CMAs (AAMA) will be current through the last day of their birth month in the 6th (sixth) calendar year following certification or recertification.

A CMA (AAMA) may recertify the basic credential by earning sixty (60) recertification points obtained by attending seminars, workshops, CMA Today articles and college classes (must relate to the profession of medical assisting). Effective January 2007, a minimum of thirty (30) of the sixty (60) recertifying points must be obtained from AAMA approved continuing education units (CEUs). Due to the increasing frequency of emergencies in medical offices and clinics, CMAs (AAMA) must maintain current provider level CPR certification at all times. Effective January 2005, a CMA (AAMA) must submit proof of current provider level CPR certification in order to certify or recertify. Effective January 2007, to recertify by CEU's the CMA (AAMA) must accumulate ten (10) points in General, ten (10) points in Administrative and ten (10) points in Clinical. The remaining thirty (30) points may be accumulated in any of the three content categories. CEU points may not be carried over from one period of recertification to a subsequent recertification period.

Recertification can also be obtained by re-taking the certification examination, which is reconstructed annually. A certification credential that is kept current identifies competent medical assistants who have met and who continue to meet the professional standards established by the AAMA.

The CMA-A (AAMA) credential indicates candidates who passed the basic certification examination and the administrative specialty exam offered through 1983. The CMA-C (AAMA) credential indicates candidates who passed the basic certification examination and the clinical specialty exam offered through 1984. The CMA-P (AAMA) credential indicates candidates who passed the basic certification examination and the pediatric specialty exam offered through 1980. CMAs (AAMA) with a specialty credential may continue to use their specialty credential without recertifying them as long as their basic CMA (AAMA) credential is current. NOTE: Subspecialty credentialing is no longer available through AAMA.

As a rule, members attending AAMA approved programs do not pay a CEU registration fee while nonmembers may pay a fee set by the program planner. The AAMA Continuing Education Department maintains a transcript of all AAMA approved courses taken by each member. Transcripts are available free to members via the members' only section of the AAMA website, www.aama-ntl.org, or by calling AAMA at 1-800-ACT AAMA. Nonmembers are required to pay a fee for a transcript copy.

Current certification and recertification promotional materials and application forms can be obtained from the National office or the AAMA website. The Certification Chair should advertise to the membership how convenient it is to recertify the CMA (AAMA) credential by phone if all CEUs are AAMA approved. This requires a credit card and member must fax or mail CPR documentation separately.

The Certification Chair should submit articles to the NSMA Editorial Chair promoting certification and recertification. NSMA should recognize newly certified and recertified members by submitting names to the publication editor for print in the Med-A-Gram on a regular basis.

Supply the President and/or Certification Chair of local Chapters and Nebraska medical assisting program directors with information regarding the certification and recertification examination; where/how to apply, eligibility requirements, application deadlines, fees, application forms, etc. Keep Chapter Certification Chairs informed of changes in the certification/recertification program and the availability of new materials from AAMA.

Attend the NSMA annual conference (or arrange for a substitute) and provide attendees with information and answer questions regarding the certification and recertification program. Work with the conference chair to arrange for a table to display certification and recertification information and offer to make a brief presentation to attendees.

At regular intervals, AAMA will mail the names of newly certified medical assistants from Nebraska to the State

President and Membership Chair. The Membership Chair should follow-up on the nonmembers by sending them congratulations and information regarding joining AAMA. The Membership Chair will then forward a copy of the list to each Chapter and suggest that the Chapters also contact nonmembers in their region and offer an invitation to the next local meeting. The Certification Chair will be given a copy of the list and will mail a letter of congratulations from NSMA to each AAMA member on the list that is newly certified. Copies of the list will also be sent to the NSMA Marketing Chair who will send notices to employers and/or the schools new CMAs (AAMA) have graduated from.

Prior to the NSMA Annual Conference (February usually works best); the Certification Chair should request the list of recertified CMA's (AAMA) obtained through CEUs during the previous year from AAMA. Send a letter of congratulations from NSMA and refer names of nonmembers to the Membership Chair for follow up.

The Certification Chair should send a personal invitation to each newly certified and recertified CMA (AAMA) from the previous NSMA conference date to attend the annual conference where they will receive special recognition. Communicate with the Annual Conference Chair to arrange a time for a brief presentation at the awards ceremony to acknowledge those in attendance. A flower, token gift and/or a certificate may be part of the production.

Chair shall maintain a current listing of practicing CMA's (AAMA) in Nebraska (both member and nonmember) that includes the year of certification, recertification, demographics and place of employment. The AAMA office will be able to help keep this list updated.

Because CMA's (AAMA) are delegated advanced patient care duties and are assigned responsibilities requiring a high degree of trustworthiness, the AAMA Certifying Board developed disciplinary standards to protect patients. Chair should be familiar with the Disciplinary Standards and Procedures for CMAs (AAMA), which includes a list of grounds for denial of eligibility for the CMA (AAMA) credential and for the discipline of the CMA (AAMA).

The year-end report from the Certification Chair should include a list of names for the new CMAs (AAMA) and recertified CMAs (AAMA) for the term.

State Leaders meeting: Director of Membership David Knight, announced some of the new website tools, the program planner guide, ELC courses, ability to print state roster/labels off the website and recertifying online. A four-member panel took turns answering questions on how they keep their chapters active and how to be a leader. One of their statements was you have to know where you are headed and have goals, without a vision there is no mission. Other areas of discussion was to host a Member Forum at your

state conferences for attendees to ask questions regarding all aspects of the AAMA. Another suggestion was to have a student ambassador recruitment program.

Another new item on the AAMA website when logged into your account is that 30 days prior to recertifying, if you get a green light, you can recertify at that time. If you do not get a green light, you will have to complete the required steps in the area below before you can continue. You will get an automated email confirmation once you have completed everything. However, you can still call the AAMA to recertify, or if it is before your 30 days of expiration, but confirmation will take 30 days to complete. AAMA will still send out reminder cards to recertifying members that are coming due.

House of Delegates
Orientation: The Delegates and
Alternates attended the HOD
Delegate/Alternate Orientation.
The session was conducted by
the Speaker of the House Paula
Purdy, CMA (AAMA) and Vice
Speaker of the House Lisa Lee,
CMA (AAMA). General guidelines were reviewed including
parliamentary procedures, the
voting process, and how to present a motion. For check-in, all

delegates and alternates are required to present their AAMA Membership Card as well as their Name Badge for entrance to the HOD. The Election of officers, trustees, and the nominating committee will be conducted by electronic ballot again this year. Turning Technologies Company demonstrated how the devices operated.

House of Delegates: The House of Delegates was called to order by Paula Purdy, CMA (AAMA), Speaker of the House. Opening reflections, presentation of the Colors, the National Anthem and the Pledge of Allegiance followed. AAMA Officers, Past Presidents, Life Members, and the AAMA staff were introduced. The report of the Credentials Chair showed the voting body as 140 possible votes with 134 registered and 6 proxy votes. The total voting power was 140, 71 was majority, and 94 was two-thirds vote.

Following the morning session of the HOD, the officer and trustee nominees mingled amongst the delegates in the audience for individual question and answer session. The issue about the surprise implementation of the Assessment-Based Recognition in order entry (ABR-OE) was discussed. When Nebraska asked a Trustee running for re-election why this was done without membership knowledge, the reply was that they were concerned for employees that had been with an office for 20 years about to lose their job because they did not have a

credential as required by the CMS's meaningful use require-Nebraska's reply was ments. why not have them go back school, utilizing one of the many CAAHEP and ABHEs accredited programs and sit for the CMA (AAMA) exam? Their response what that they did not feel these people would want to go back to school at their age nor could afford the programs. This did not sit well for many reasons with the Nebraska delegation. Unfortunately, there was not enough time allocated to visit with all of them.

At the Reference Committee, all officer and committee reports were open for discussion.

The House of Delegates reconvened and the voting power remained the same at 140. Both Nina Watson, CMA (AAMA), CPC and Donald Balasa, JD, MBA presented a very long synopsis of the birth of the Assessment Based Recognition in Order Entry in order to try to justify having adopted it without discussion during an annual conference or HOD.

This was the second year Delegates used electronic "clickers" to vote. This method worked very efficiently but unfortunately, the proceedings was a fiasco since the Parliamentary Advisor did not understand what to do with the election results.

Unfortunately, Susan Hawes, CMA (AAMA) was deemed not elected by the HOD leaders even though out of the five (5) times the Delegates voted for Trustees, she received the majority votes during the first two voting episodes. During the Presidents Luncheon, the BOT announced that they offered Susan Hawes, CMA (AAMA) a one-year term as Trustee due to the mass confusion at the HOD on Sunday. Nebraska Delegates question the Board of Trustees role in the HOD and overstepping their boundary when they offered Susan Hawes, CMA (AAMA) a 1-year term.

Completing the 2nd year of their two-year term as Trustees were Patricia Hightower, CMA (AAMA), Freda Miller, CMA (AAMA), PCS, and

K.M., CMA (AAMA) PhD.

Another issue that was discussed with a Trustee was that the Delegates should not be voting for the top three Trustees all

at once. Every Trustee running should have a chance of earning all possible votes in the HOD and not being elected by majority vote.

Bylaws adopted at the HOD:

Article VI – Membership, Section 2, Qualifications. A. ACTIVE – An active member shall be one of the following: 2. Anyone who was an active member on 12/31/87, who has never been a CMA (AAMA), and who has maintained continuous active membership. Continuous active membership shall be defined as having dues postmarked or submitted electronically to the AAMA Executive Office by December 31 (the controlling time is that of sending, not receiving).

<u>Resolutions:</u> There were no Resolutions presented this year.




