The 2009 House of Delegates will be asked to officially approve the manual but it is currently available through the Document Committee Chair to any member who would like to preview the contents.

The Policy Manual was developed to help both new and experienced members understand and sort through the responsibilities of NSMA leader-

ship positions. The Manual contains information regarding the roles of elected Officers as well as the Standing Committees and helps to define the duties of these positions. The Manual offers advice for meeting protocols, reviews standard policies, presents leadership tips and much more.

This Manual will help NSMA move forward with projects and ideas by establishing a well documented written base to build on. As we are able to incorporate more active plans into our

Delegates Reports

Summary of Delegates and Alternates reports from the 52nd Annual AAMA Conference in Chicago, Illinois October 17-21, 2008

This year's theme was "**My Kind of Conference**," with 907 registrants as of Saturday.

Highlights from the Board of Trustees/Endowment Meetings:

Roll call was taken and the gallery was introduced with having 100% of Nebraska's Delegates/Alternates in attendance.

The Board of Trustees indentified a marketing relationship with Professional Association of Health Care Office Managers (PAHCOM) but discussion was held on whether that should continue due to the expense. The AAMA is strengthening ties with PAHCOM as part of an initiative to reach out to hiring decision makers about the CMA (AAMA). AAMA had an exhibit at this conference and 218 out of the 217 attendees stopped by the booth asking about information on the CMA (AAMA).

AAMA Executive Director Donald Balsa, JD, MBA, talked about strategic issues planning. They prioritized outreach marketing efforts and looked at funding to attend different types of conventions that place a high priority on CMAs and developing a strategic plan timeline. During this time they will develop a mission and vision statement, the committee will look to develop a value statement. A committee is working to present a new plan at the winter board meeting in hopes that the AAMA representatives will be able to bring it to each state annual conference. Don wrote an article for the *Journal of Medical Practice*

Management which could create increased recognition and distinctiveness of the CMA (AAMA).

The Advanced Practice Document was updated due to the changes in the Occupational Analysis of the CMA (AAMA) for more advanced CMAs. This was discussed and voting to approve was deferred to the next BOT meeting. Discussion dealt with emergency preparedness planning and community response planning for disasters, and defined the roles of the administrative management role verses lower level CMAs. It was brought up that the wording needs to be clear and precise for all to understand as written, and educators need to be aware of these changes and implement them into their curriculum.

At the State Society Committee request, the Board allocated funds for a survey and mailing to members in the state of Louisiana, in response to possible interest in forming a state society (there has never been a state society in Louisiana). Funds for postage and stationery for the survey in Louisiana - approved. The Board will assist as much as possible to establish this affiliate. It was mentioned that there are some state societies that are becoming stronger again after a dormant period.

Changes may be forthcoming on the AAMA Mentoring section as there is currently little activity generated from this site.

The Board received questions about the CMA (AAMA) credential, particularly on how to verify the status of the credential.

The Board stated that not all states are tri-level membership, some are just bi-level.

The Board stated that Oklahoma will be issued their charter and Arkansas's charter will be reissued.

The Board dissolved the task force on telemedicine due to the fact the charge was completed.

The Board discussed AAMA contacts with the military to make a connection for the CMA role in the military.

President and President Elect Advisory Council on Friday:

The Leadership and Mentoring Team presented a Mentoring session on how all states need to work together to keep the AAMA going. They also gave us a "pep" talk on the mentoring of members and how it was crucial to the tri-level organization. Several requests from members were shared with the group:

- Adding the State affiliation name to members listed on the conference program roster.
- Reorganizing the list of new CMA (AAMA)s on the website so they are grouped by states and in alphabetical order.
- AAMA developing a learning module for all new medical assisting program directors.
- Exploring possibilities of holding meetings and member discussions online, i.e. chat rooms.
- Creating an "alert" on the website when there are special notices or when the website is updated.

David Knight informed us that the CEU attendance form is in an Excel spreadsheet, that can be

completed online now and our transcripts will be updated daily now.

They are looking into finally doing all identification with the membership number and not the member's social security number and finding a way to identify non members that submit CEUs.

Electronic Learning Center (ELC) (obtaining CEUs) will be available online at the AAMA website by the end of the year and available 24/7 and you will have your results in 72 hours. These will be different from those offered in the *CMA Today*. It will be \$7 for members and \$15 for non members. Another positive step forward in helping members keep up on their CEUs and staying certified. The Board was asked to consider allowing CEUs to be earned for serving as a delegate and for active AAMA involvement. This was taken under advisement.

Membership and Marketing did a skit with "Henry the Hand" on hand washing.

This is a free promotional idea that states/chapters can use to promote themselves and the CMA (AAMA) through reminding the public to stop the spread of disease by washing their hands. Check out the website for things you can download and use at: www.henrythehand.com.

The **Career Moves** videotape was updated and transferred to a DVD format and each state was given one and others are available for purchase. The Career Moves DVD can be used as a marketing and membership tool.

Linda Brown, CMA (AAMA), AAMA President then asked the group for concerns/questions. Some of the thoughts were: watching for drop in membership due to the economy, to clarify the conference program to add the states behind the members

names listed in the program and to match the speaker to the conference topic, discussed online CEU's and how it may affect chapter/state membership, marketing the CMA, conference costs, new program director classes to be held at AAMA conference, how member-at-large is assigned, and how states can make changes. Did you know that dues to AAMA have not been increased since 1992?

Leadership A Training HOD DELEGATES AND ALTERNATE ORIENTATION:

This session covered the general information, the purpose of a resolution, who may present a resolution, submission date, emergency or late resolutions, procedure on presenting a resolution, process of review of the resolution, checklist for submitting a resolution, action by the Board of Trustees, how to format a resolution, provided a sample of a proposed resolution prior and after review of the Board of Trustees. They also handed out "The ABCs of Parliamentary Procedure" booklet and a parliamentary procedure at a glance guide.

Delegate, Carol Muske, CMA (AAMA) was Chair of the Resolutions committee this year. During the Leadership A training they had the orientation of the committees on credentials, pages, tellers, and reference. They were instructed how to handle their duties during the HOD on Sunday.

Leadership B Training:

Leadership B is now presented as the final session on the last day of the conference and is worth 2 CEUs. All delegates are required to attend the Leading with Impact session. This session covered leadership

concepts, medical assistants: leaders at work; linking leadership to patient outcomes; and coaching and mentoring strategies for AAMA chapters. Leaders provide balance in an organization, good employees become leaders but they don't always have the skills for leaders. She did talk to us on being effective CMA (AAMA), leaders at work, mentoring in the AAMA. She did give us a handout for developing a leadership plan with employees, as a group and individually. She also researched the Bureau of Labor Statistics website and found that medical assisting has the fastest growth rate of all professions.

Other topics of interest at the Conference:

Attending conference was Mary F Dunham, from Montana; she has been an AAMA member for 51 years.

The MAERB presented a program regarding the implementation of the 2007-2008 Occupational Analysis for CMA (AAMA) in medical assisting programs. The major changes included rewording the description of the profession, deleting the requirement for having a physician medical advisor on the Board, the addition of a practicum (replaces the term 'externship'), coordinator and the program director requirements have been changed to include a minimum of three years experience. CAAHEP has established the standard requiring an exit exam by every graduate with a five year window to achieve results. MAERB has established the outcome standard at a 70% pass rate. More information is available on the AAMA website under the endowment tab.

Again the Continuing Education Board presented four

electronic media presentations for CEUs. Members watched a power point presentation, took a test and received one CEU for each topic if they scored 80% or higher on the test. There was a new topic each day, Friday through Monday.

The AAMA joined in going "Green" this year. Recycling containers were available to members to recycle cans, bottles, and paper materials this year. The AAMA also feel that doing CEUs online will cut down on paper use and staff time.

Since our conference was held in Chicago, home of the AAMA, a lot of the headquarter and registration table time was taken care of by the AAMA staff from the home office, thus allowing members to be able to attend more of the conference rather than spending time volunteering to cover these areas. It could not be verified, but was heard that the AAMA was going to allocate money to future conferences to hire temporary help in conference cities to handle these duties from now on and rely less on members to do these jobs.

Nebraska had a Ways and Means table selling all of the polo shirts and sweatshirts we had taken with us. The members took turns at the table and monitor sessions on Saturday.

Certifying Board General Session: Computer-based testing for the CMA (AAMA) Exam.

After years of waiting the Certification test is finally available online and will be offered every month after the initial setup period beginning 2009. Candidates must be graduates from an accredited CAAHEP or ABHES medical assisting program. Exam fees for students, recent graduates and AAMA members of \$125 and you will be

given an unofficial pass/fail at the end of the test beginning April 1, 2009. For non-recent graduates and recertificants who are not AAMA members the fee is \$250. Personal checks are not accepted but you can pay by money order, cashier or certified check, and credit/debit card. Candidates have a 90 day testing period where they can only take the exam once and if they fail to take the exam they lose their exam fee. All fees are non-refundable and non-transferable.

The test consists of 200 questions covering General, Administrative, and Clinical with 20 pretest question randomly distributed throughout the exam which are not graded but used for testing data.

The exam takes approximately 3 hours and 15 minutes with an optional 20 minute break. Starting November 1, practice tutorial and sample questions will be available on the AAMA website at www.aama-ntl.org. Prometric is the network in charge of the testing sites nationwide, which is the same system that doctors use for their testing. Don Balsas, JD, MBA, presented the undeniable evidence that the CMA (AAMA) has always been, and continues to be, the "gold standard" of medical assisting credentials. Charles Reed, MD, presented a physicians perspective on why the National Board of Medical Examiners' (NBME) role as test consultants of the CMA (AAMA) Exam bespeaks quality and integrity to American physicians. Nebraska has 2 members who serve on this committee, Jan Frederick, CMA (AAMA) and Linda Allensworth, CMA (AAMA), CPC.

The mechanics and details of the CBT were presented by the Certifying Board members Deb Rossi, CMA (AAMA), and Diane VanderPloeg, CMA (AAMA). Of

particular note was the fact that students in CAAHEP and ABHES accredited medical assisting programs will be able to sit for the CMA (AAMA) Exam as early as 30 days before completion of all program content including externship/practicum. Also, unofficial pass-fail results will be provided to examinees immediately upon completion of the test. The candidate will not be CMA (AAMA) certified until scores are official; official results forthcoming six-ten weeks after the test.

NBME Assessment Officer Brent Pierce presented additional details about CBT, and explained how the encryption of the tests will provide maximum security. The standardized processes at all Prometric test centers will ensure a consistent and reliable examination experience for all candidates.

House of Delegates:

We did not have a keynote speaker this year, so that we as Delegates could get to the business of the day.

Speaker of the House, Boni Bruntz, CMA-A (AAMA), called the HOD to order and introductions were made.

Oklahoma received their charter and their Delegates were seated at the 52nd Annual House of Delegates.

Cindy Larson, CMA (AAMA), from Arkansas was given a replacement charter after theirs was destroyed.

The report of the credential chair stated the following: voting power-129; registrants-126; proxy votes-1; total voting power-127; majority vote-65; two-thirds vote-85.

Illinois State President Patricia Bean, CMA, (AAMA) gave the welcome. The agenda was approved and the proclamation was read by the Conference Chair from the Mayor of Rosemont, the Mayor of Chicago, the Governor of Illinois, and letters were read from the AMA President and from Senator Barack Obama. AAMA President Linda Brown, CMA (AAMA), gave a supplemental report about PAHCOM and efforts to reach office managers. Rules of the House were approved.

Nominations were taken from the floor for the offices of Vice President, Vice Speaker, Speaker of the House, Trustees and Nomination Committee. Andrea Stewart CMA (AAMA) ran for nominating committee but, unfortunately, was not voted in.

Roberta Antrim, CMA-A (AAMA), MHR, was recognized

for her lifetime of dedication to the association. 12 other AAMA Life Members were honored.

K.M., PhD, CMA (AAMA) gave a tribute to two members who have passed on.

Reference Committee Reports were presented on:

Bylaws - Proposed Bylaw Amendment 08-01; 08-02; 08-03; and 08-04 all had to deal with Officer and Trustee qualifications. Instead of having served two years as a member of the Board of Trustees, Chair of Certifying Board, Curriculum Review Board or Continuing Education Board, all proposals sought candidates within the most recent five AAMA years, have served two complete AAMA years as a HOD elected member of the Board of Trustees. Again, after much discussion and confu-

sion, these were all defeated and referred back to the committee.

Resolutions - Carol Hipke-Muske, CMA (AAMA), served as chair of the Resolutions Committee.

08-1 regarding the governance of AAMA and 08-2 regarding the annual medical assisting summit.

Much discussion took place over the resolutions and they were withdrawn by request of states (CA and PA) that introduced them. The HOD approved to withdraw both Resolutions.

We had the opportunity to meet and visit with most of the candidates and caucus before Delegates voted.

Donald Balsa, JD, MBA, reported he had received emails regarding 6-8 week medical assisting programs and is working with the Federal Trade Commission regarding certification mills.
